## Vicksburg Community Schools Safe to Return to In-Person Instruction and Continuity of Services Plan 2022-2023

Under the interim final requirements, an LEA plan for safe return to in-person instruction and continuity of services must describe how the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the prevention and mitigation strategies recommended by the CDC.

Vicksburg Community Schools is beginning the 2022-2023 school year without any special COVID protocols in place and will follow the Kalamazoo County Health Department COVID-19 guidance for isolation and quarantine.

Current CDC guidelines state that those with a positive COVID-19 test must quarantine for 5 days following the onset of symptoms or a positive test and may return to school on day 6. It is recommended you wear a mask through day 10.

We are asking families to notify their child's school if their child tests positive for COVID-19 as they would with any other contagious illness.

We are aware that the virus is still prevalent and contagious. Although masks are not required, anyone who chooses to wear a mask may do so on a voluntary basis. We also encourage anyone who is eligible to get the vaccine and recommended boosters.

Continued Health and Safety Protocols include enhanced cleaning protocols, multiple hand sanitizing stations in buildings and classrooms and encouraging hand washing and covering of mouth while coughing or sneezing.

The plan must also describe how an LEA will ensure continuity of services, which must address students' academic needs and students' and staff social, emotional, mental health, and other needs, and which may include student health and food services.

To ensure continuity of learning and instructional services and to address learning loss, Vicksburg Community Schools will provide full in-person instruction five days per week at all levels Pre-K through 12 with the exception of Vicksburg Pathways High School that runs on an alternative schedule as a part of its innovative programming. Full time substitute teachers in each building will be provided to prevent disruption of in-person learning.

Benchmark Assessment data will be reviewed in the fall, winter and spring to ensure that students are showing progress in their learning. Adjustments deemed necessary by the data reviews will be implemented without delay. Based on an ongoing analysis of data (formative, benchmark, summative), students will be identified for and receive targeted interventions and support in addition to in-class instruction. The district framework for operating as a Professional Learning Community including a Multi-Tiered System of Supports is in the process of being reviewed and renewed and will be an area of focus throughout the school year to ensure high levels of learning for all students.

The social and emotional needs of both staff and students will continue to be an area of focus in our district.

Counselors are available in each building as well as behavior specialists and a school social worker. These positions are assisting us with meeting the social, emotional, and academic needs of all students. A social-emotional screening tool will be developed and implemented as part of our ongoing MTSS work. This screening tool will provide data to help staff address needs of individual students as well as groups in need of intervention. Additions in staffing this year include a Student Support Coordinator at Sunset Lake Elementary (1.0 FTE), a Student Services Coordinator at Vicksburg Pathways High School (.5 FTE), and an SEL Coordinator at Vicksburg High School (.5 FTE). Professional learning opportunities for all staff related to social emotional health and well being are available on-demand as well as scheduled in December and March. The district framework for Social Emotional Learning is in the process of being defined and will be communicated fully by the end of the school year.

In addition, the LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services, and must seek and take public input into account in determining whether and what revisions are necessary.
